II. COURSE OBJECTIVES: *Course will:*

1. Give each student an opportunity to a planned, supervised work experience in the field of employment which they have pursued educationally.
2. Provide the student with the opportunity to experience the "real world" of employment and it's surroundings.
3. Expand breadth of knowledge and expertise in horticulture or turfgrass management.
4. Enhance ability to adapt to changes in technology.
5. Further, develop and enhance ability to communicate with coworkers and supervisor.
6. Develop leadership skills and qualities, to become outstanding leader and team players within the horticulture and turfgrass management industry.
7. Demonstrate professional behavior, appearance and attitude.
8. Demonstrate punctuality and self-discipline.
9. Accept responsibility for tasks assigned.
10. Develop and enhance networking abilities.
11. Analyze issues, problems and situations in the field.
12. Allow students further develop time management skills.
