I. CATALOG DESCRIPTION

Course Number: ECED 1220
Course Title: Pre-Practicum
Prerequisite(s): None
Co-requisite(s): Co-requisite with a student's first practicum. That could be ECED1630, ECED1610, ECED1620 or ECED1640.
Catalog Description: This course is designed to prepare students for practicum experiences in early childhood settings. A review of the various practicum settings, forms, policies, procedures, and best practices will be covered. Students will complete the appropriate background checks as required by childcare licensing. An understanding of childcare licensing standards, roles, responsibilities, expectations of the practicum student, professionalism, supervision, and the evaluation process will be covered.

- E. Require students to complete a criminal background check, including fingerprinting and obtain release forms for all appropriate state agencies.

- G. Review the ethics and professional expectations of practicum students as determined by the cooperating site and the college early childhood education program.
- H. Identify the procedures for addressing problems or withdrawing from practicum.
