Course Title: Medical & Psychosocial Aspects of Alcohol/Drug Use, Abuse & Addiction

The education includes drug classification and basic pharmacology of drugs and their effects, as well as the processes of dependence, addiction and withdrawal covering signs, symptoms and behavior patterns.
