Course Title: Children's Literature
Prerequisite(s): A grade of "C" or higher in ENGL1010 or a grade of "C" or higher in ENGL1054.
Catalog Description: Survey of the various genres of children's literature with an emphasis on methods of critically evaluating, analyzing, and sharing both traditional and recent selections.

- C. Give students the tools to critically evaluate the quality of children's literature.
- D. Familiarize students with the various genres of children's literature and their characteristics.
- E. Provide students with a framework for understanding the layout and design of children's literature and the relationship between text and illustrations.
- F. Familiarize students with children's literature journals.
