I. CATALOG DESCRIPTION

Course Number: PTAS1301
Course Title Clinical Education 1
Prerequisite(s): PTAS1208, PTAS1209, PTAS1210

Catalog Description: A clinical experience where the student will have the opportunity to apply classroom theory and laboratory practice learned to date to direct patient care in a selected clinical setting. The intent is for the student to provide quality patient care with a high degree of guidance, cueing and assistance from the clinical instructor. Course to include pre-clinical orientation and post-clinical debriefing.

II. COURSE OBJECTIVES: *Course will:*

1. Apply classroom theory and laboratory practice to direct patient care in a selected clinical setting.
2. Prepare student to provide quality patient care with a high degree of guidance, cueing, and assistance from the clinical instructor.

15. Analyze similarities and differences between physical therapy practice in rural (outside of Lincoln and Omaha) areas and urban facilities.

- Performance on CPI (*The CI and the student will complete the Clinical Performance Instrument at mid-term and at the end of the clinical experience.*) *At the completion of Clinical Education I the student will demonstrate marks at a Minimum of Advanced Beginner performance on the CPI rating scale for all 14 criterions, including all "red flagged" items.*
